This privacy policy should be read in conjunction with our Terms and Conditions.

This policy explains what information CRIMPIC (JOTIKA LIMITED) collects about Subscribers of the Site and how we use this information.

1. Collection and Use of Personally Identifiable Information

CRIMPIC (JOTIKA LIMITED) only collects personally identifiable information that is volunteered by Subscribers during the registration process or in response to specific information requests presented directly to Subscribers. CRIMPIC (JOTIKA LIMITED) only collects information that is necessary for us to perform our business and provide this service to you.

We may use third parties to supply and deliver security services. In this case it is necessary to share your personal information for fulfillment purposes. These third parties are prohibited from using your personal information for any other purposes.

Crimpic (Jotika Limited) may be required to produce personal information or data stored by the Subscriber on the Crimpic Server to Law Enforcement Agencies, Officers of the Courts or any authorized person or organization by way of subpoena or equivalent. These forms will clearly identify the identity and contact details of the organization collecting the personal information, and the information you provide will be managed according to the privacy policy of that third party. In the event that you complete a web form hosted by us, we will only disclose the specific information provided by you to that third party.

With the exceptions listed above, we WILL NOT edit, modify or disclose your personally identifiable information to any third party without your permission unless we believe such action is necessary to:

- Conform to legal requirements or comply with a legal procedure as set out in the jurisdiction of any country or region;
- Protect and defend CRIMPIC (JOTIKA LIMITED)'s rights and property;
- Enforce the CRIMPIC (JOTIKA LIMITED) Terms and Conditions (Terms); or
- Protect the interests of our subscribers or others.

We may access your account, including its contents, as stated above or to respond to service or technical issues.

2. Collection and Use of Non-Personally Identifiable Information

CRIMPIC (JOTIKA LIMITED) collects and stores general information about our Subscribers and their activity on our site and affiliated sites so that we can improve our offerings and tailor content on our site and affiliated sites to meet the interests of our Subscribers. The information we collect includes the non-personally identifiable information volunteered during the registration process or in response to specific information requests presented directly to Subscribers. Wherever possible, we will use the information we hold to improve the relevance of surveys and if applicable, email promotions that we send to Subscribers.

CRIMPIC (JOTIKA LIMITED) servers automatically record your IP address, your browser type and operating system when you access our site. We may use this information to help diagnose problems with our server, administer our web site and compile aggregate user information for our support team. If we detect fraud or abuse of our system we may use the IP address of a user in order to identify them.

CRIMPIC (JOTIKA LIMITED) uses Cookies to personalize your experience and identify you when you are logged in to our site. We may also use cookies to estimate our audience size and measure traffic to, and usage of, our web site.

3. Data Security

Personally identifiable information collected by CRIMPIC (JOTIKA LIMITED) is stored in accordance with our site security policy and we take reasonable steps to ensure that member information is secure from unauthorized access, modification or disclosure.

4. Access & Correction

Personally identifiable information collected by CRIMPIC (JOTIKA LIMITED) can be accessed and updated by the Subscriber by using the facility provided on the Site (you will be required to log in first).

5. Linked Sites

The CRIMPIC (JOTIKA LIMITED) Site, the communications we send you, and if applicable, the email promotions we send you may provide links to our partner and advertiser web sites. If you link to any of these Third Party sites this policy will not apply to your use of those sites.

6. Frequency of email communications

All email communications that result from your CRIMPIC (JOTIKA LIMITED) Subscription will be sent directly from us and will prominently identify CRIMPIC (JOTIKA LIMITED) and our contact details.

7. Changes to this policy

CRIMPIC (JOTIKA LIMITED) reserves the right to update this policy from time to time, in part or in whole. Depending on the nature of the change we may, at our sole discretion, either announce the change on our web site or notify Subscribers by email. If you do not agree with this privacy policy in whole or in part, or if you do not agree with changes made to this policy, you must terminate your account.
